DOCUMENTS CHECKLIST



1. Visa Application Form

- Fully filled and signed.
(At the time of Visa Application Submission at Anatolia Visa Services)

2. Passport

- Original passport valid for at least 6 months from travel date.
- Must have 2 blank pages.
- Attach all old passports (if available).



3. Photographs

- 4 recent passport-sized photos.
- White background, biometric, not older than 6 months.

4. Cover Letter

- Clearly mention your purpose of visit, duration, travel itinerary, and who will bear the cost.
- Signed by the applicant.

5. Flight Reservation

- Dummy or confirmed return ticket
(not necessarily paid).

6. Hotel Booking

- Dummy or confirmed hotel reservation, matching the visa duration.

7. Travel Insurance

- Valid for Turkey and Schengen countries.
- Coverage of at least €30,000 for emergency medical needs and repatriation.

8. Financial Proof

- Last 3–6 months bank statements with sufficient balance (preferably PKR 600,000+ per person).
- Bank account maintenance letter on bank letterhead.



9. Employment/Business Documents If Employed:

- Employment letter on company letterhead (mentioning job title, salary, joining date, and leave approval).
- Last 3 salary slips.
- NTN or tax certificate if available



If Self-Employed:

- Business registration documents (e.g., SECP certificate, NTN).
- Business bank statements.
- Last 2 years tax returns (if applicable).



If Student:

- Student certificate from educational institution.
- NOC for travel from school/college.

10. FRC or Family Documents (if traveling with family)

- Marriage Certificate (if spouse is accompanying).
- Family Registration Certificate from NADRA.
- B-form of children (if minors are traveling).

11. Property or Asset Proof (Optional but Strongly Recommended)

- Property ownership documents, vehicle registration, or any other asset proofs to show ties to Pakistan.

12. CNIC Copy

- Clear copy of Pakistani National ID Card.

13. Visa Fee Receipt

- Visa fee is approximately PKR 50,000 to 60,000 payable at Gerry's Visa Center.

Additional Notes

- Personal appearance is must for biometric data.
- Processing time: 20–25 working days (can vary).
- Incomplete or fake documents can lead to refusal.
- Booking through a registered travel agent can help avoid errors.
