1. PASSPORTS

- Valid Passport copies of the main applicant, spouse, and children under 18
- Must be translated into Turkish and notarized in Turkey



2. FAMILY REGISTRATION CERTIFICATE (FRC)

- Issued by NADRA (can be obtained online)
- Must show full family tree (main applicant, spouse, and children)
- Must be attested by the Ministry of Foreign Affairs (MOFA), Pakistan)
- Must be translated into Turkish and notarized



3. MARRIAGE REGISTRATION CERTIFICATE (MRC)

- Issued by Union Council or NADRA
- Must be attested by MOFA Pakistan
- Must be translated into Turkish and notarized in Turkey
- Certificate of Single/Unmarried Status (if not married)

Note: If divorced or widowed, include Divorce Certificate or Death Certificate (attested + translated + notarized)NTIE



4.BIRTH CERTIFICATES (ALL FAMILY MEMBERS) (MRC)

- Issued by Union Council or NADRA
- Must be attested by MOFA Pakistan
- Must be translated into Turkish and notarized in Turkey



5. POLICE CLEARANCE CERTIFICATE

- Valid Police Character Certificate
- Must be issued within the last 6 months by local police or district authorities
- Must be attested by MOFA Pakistan
- Must be translated into Turkish and notarized in Turkey



6. BIOMETRIC PHOTOGRAPHS

- 6 biometric photos per applicant
- White background, 50x60 mm, ears visible



7. CONSENT LETTER / POWER OF ATTORNEY (FOR CHILDREN UNDER 18)

- Signed by both parents, giving consent to include children in the application
- Must be attested by Turkish Consulate or issued by Local Notary in Turkey.



8.TURKISH TAX NUMBER

- Required for main applicant and spouse
- Can be obtained online or at any local tax office in Turkey
